Our Dried Citrus Pulp Pellets are a co-product derived from the juicing of citrus fruits such as oranges, lemons, limes, and grapefruits. The pulp is composed of peel, membranes, and residual juice sacs, which are subsequently dried and pelleted for ease of handling, storage, and transport. This product is primarily used as a high-fiber, energy-rich feed ingredient in ruminant animal diets.
